Dr. DaMia Harris-Madden has spent 18 years working at the intersections of government, education, business, and the non-profit sectors. Dr. Madden entered the private sector immediately after receiving a bachelor's Degree in English and African American Studies as a Human Resources Manager. She achieved both a Masters of Science in Human Resource Management and a Masters of Business Administration. Eventually, Dr. Madden transitioned into the government sector where she has held leadership positions in local and county government, and successfully completed a Doctorate in Education and Executive Leadership.

After serving within four mayoral cabinets, she accepted the role as the Executive Director of the Westchester County Youth Bureau, an office of the County Executive, George Latimer in 2018. She is currently responsible for managing a department that deploys financial and technical resources to non-profit, private, and municipal agencies that support children, youth, and families within the 46 communities throughout Westchester County. She also serves as a writing instructor to doctoral students who are enrolled in St. John Fisher College.

Known for her expertise in grant writing and program evaluation, Dr. Madden has secured millions of dollars in federal, state and private funds.
